Coverages and Covenants

FCF DSCR was 1.6 times and the EBITDA to Debt Service ratio was 1.6 times for the Relevant Year and 1.5 times and 1.6 times respectively for the Relevant Period. The Debt Service Covenant and Restricted Payment Condition were satisfied.

Net Worth as at 3 January 2015 was £508.5m. Restricted Payments of £11.0m were made in Q1 and £26.0m during the Relevant Year. The Restricted Payment Maximum at 3 January 2015 was £11.7m and no calculation of the Further Restricted Payment Maximum was required.

Maintenance and Capital Enhancement

The cumulative Maintenance Expenditure* in the Relevant Year was £18.6m and the Relevant Period was £9.1m. The Required Maintenance Amount* for the Relevant Year was £15.9m.

Capital Enhancement Expenditure of £4.4m was made in Q1, £16.6m in the Relevant Year and £9.7m in the Relevant Period.

*Maintenance includes both capital items and items expensed through the profit and loss account.
